## **GDPR Data Protection Declaration**

In order to process your data as a sponsor within the AMPO International e.V. charity association, to contact you in connection with activities of the charity and to process your standing order, we shall collect certain personal data from you. Pursuant to GDPR Art. 13 (1) and (2) we hereby inform you of your rights concerning the data we store and process.

### **Name and contact data of the controller**

AMPO International e.V. with headquarters in Hamburg is recognised as a non-profit organisation by the tax authorities. The legal representative of AMPO International e.V. is the Board. The Board may be reached by email at [vorstand@ampo-int.org](mailto:vorstand@ampo-int.org). The current statutes and the names of the current members of the Board may be found on the internet under [www.ampo-intl.org](http://www.ampo-intl.org).

### **Purposes of the processing for which the personal data are intended**

The personal data are processed to establish the sponsorship relationship. In effect and inter alia the data are used to make contact in connection with activities of the charity, for invitations to meetings and other events, for the purpose of updating contact details, for queries relating to sponsorship payments, for providing information material, for accounting purposes and for the issue of donation receipts.

### **Lawfulness of processing**

The processing of personal data is conducted on the basis of your consent pursuant to GDPR Art. 6.

### **Recipients of your data**

Your name, first name, address, amount and bank details will be forwarded to GLS Bank when setting up a standing order.

### **Period for which the personal data will be stored**

Your personal data will be stored and updated for the duration of the sponsorship. On termination of the sponsorship the data will be preserved for fiscal reasons for 10 years and then deleted.

### **Right of access, erasure, restriction**

You have the right to information free of charge concerning your stored personal data, their origin and recipients and the purpose of data processing. You may have them rectified, blocked or erased at any time (unless the tax authorities have a higher right, c.f. "Period for which the personal data will be stored"). You also have the right to restrict or contest the processing of your personal data.
